BROOME COUNTY LEGISLATURE SPECIAL SESSION

Tuesday, November 10, 1992

The Legislature convened at $2:00~\mathrm{p.m.}$ Called to order by the Chairman, Arthur J. Shafer.

The Clerk, Richard R. Blythe, read the fire exit announcement and then called the Attendance roll: Present-17, Absent-2 (Mrs. Wagstaff, Mr. Pazzaglini came in after roll call).

The Chairman, Mr. Shafer, led the members of the Legislature in the Pledge of Allegiance to the Flag, followed by a moment of silent meditation.

ADD: NUMBER 11.ONE DAY BEFORE APPROVED FURLOUGH - INMATE MUST SUBMIT TO URINE TESTING FOR NON-PRESCRIBED DRUGS. IF THE TEST IS POSITIVE THE FURLOUGH IS CANCELED AND INMATE LOSES CONSIDERATION OF FUTURE FURLOUGHS FOR BALANCE OF SENTENCE.ANY OTHER DISCIPLINE IS AT THE DISCRETION OF THE SHERIFF OF BROOME COUNTY.

ADD; NUMBER 12THE DAY OF RETURN FROM FURLOUGH - THE **INMATE** MUST **SUBMIT** TO URINE AND BREATHALYZER TESTING FOR NON-PRESCRIBED DRUGS. IF THE TEST IS POSITIVE INMATE LOSES **FURLOUGH PRIVILEGES FOR BALANCE** OF SENTENCE. ANY OTHER DISCIPLINE IS AT THE DISCRETION OF THE SHERIFF OF BROOME COUNTY.

RESOLUTION NO. 517 by the Public Safety & Emergency Services Committee authorizing renewal of agreement with Broome County Council on Alcoholism for the special traffic options program for driving while intoxicated (STOP-DWI) program for 1993 which was held over by Mrs. Coffey at the November 5, 1992 session was again presented for consideration. **Carried.** Ayes-19, Nays-0.

RESOLUTION NO. 518 by the Public Safety & Emergency Services Committee authorizing renewal of funding agreements with the Broome County Sheriff's Department and various municipalities of the special traffic options program for driving while intoxicated (STOP-DWI) program for 1993 which was held over by Mrs. Coffey at the November 5, 1992 session was again presented for consideration. **Carried.** Ayes-19, Nays-0.

RESOLUTION NO. 519 by the Public Safety & Emergency Services & Environment Committees adopting statement of findings and decision pursuant to state environmental quality review act with respect to proposed Broome County Public Safety complex which was held over by Mr. Kavulich at the November 5, 1992 session was again presented for consideration. **Carried.** Ayes-13 (Augostini, Bielecki, Coffey, Howard, Malley, Moppert, Pasquale, Pazzaglini, Schofield, Seeley, Warner, Yeager, Shafer), Nays-6 (Brown, Greenmun, Hudak, Kavulich, Lindsey, Wagstaff).

RESOLUTION NO. 522 by the Finance Committee adopting the Broome County budget for fiscal year 1993 which was held over by Mr. Shafer at the November 5, 1992 session was again presented for consideration. The Chairman recognized Mr. Schofield for the presentation of the Finance Committee report. Following an explanation of the budgetary process Mr. Schofield indicated that no report would be presented at this time. Mr. Yeager moved to call the question, seconded by Mr. Pazzaglini on the budget resolution. Motion to call the question **Carried**. Ayes-17, Nays-2 (Kavulich, Malley). Resolution as presented **Lost**. Ayes-8 (Brown, Coffey, Kavulich, Malley, Moppert, Pasquale, Seeley, Shafer), Nays-11 (Augostini, Bielecki, Greenmun, Howard, Hudak, Lindsey, Pazzaglini, Schofield, Wagstaff, Warner, Yeager). The defeat of this resolution allows the County Executive's original budget of October 15, 1992 to go into affect with no changes other than those authorized by the following resolution; No. 523.

RESOLUTION NO. 523 by the Finance Committee making appropriations for the conduct of the Broome County Government for fiscal year 1993 which was held over by Mr. Shafer at the November 5, 1992 session was again presented for consideration. **Carried.** Ayes-12 (Augostini, Bielecki, Brown, Coffey, Kavulich, Lindsey, Malley, Moppert, Pasquale, Pazzaglini Seeley, Shafer), Nays-7 (Greenmun, Howard, Hudak, Schofield, Wagstaff, Warner, Yeager).

RESOLUTION NO. 524 by the Finance Committee approving the 1993-1998 Capital Improvement Program which was held over by Mr. Shafer at the November 5, 1992 session was again presented for consideration. **Carried.** Ayes-11 (Bielecki, Brown, Coffey, Kavulich, Lindsey, Malley, Moppert, Pasquale, Schofield, Seeley, Shafer), Nays-8 (Augostini, Greenmun, Howard, Hudak, Pazzaglini, Wagstaff, Warner, Yeager).

RESOLUTION NO. 525 by the Finance Committee establishing 1992 equalization rates for 1993 county tax levy which was held over by Mr. Shafer at the November 5,

1992 session was again presented for consideration. Mr. Brown moved, seconded by Mrs. Wagstaff to **table** this resolution to the November 24, 1992 session. Motion to **table Carried.** Ayes-19, Nays-0.

Mr. Pasquale moved, seconded by Mr. Yeager to adjourn to the call of the Clerk at 2:27 p.m. Carried.
